**Minutes**

The minutes of the 178<sup>th</sup> meeting, held on 1 November 2016, were confirmed, subject to changing the last sentence under 'Kaiwharawhara Point' on p.2 to: "Four non-notified resource consents have been approved by GW and one by WCC. If the project is approved by the CentrePort Board, the work could commence by the end of the year or early in 2017. CentrePort Board is meeting in November to look at the proposal". **Barbara Mitcalfe**

Sadly, Barbara Mitcalfe of BotSoc died early this year. She helped TPG on several occasions with her botanical knowledge and was a great advocate for the environment. The 'Wellington Regional Native Plant Guide', which she contributed to, is in constant use by TPG.

**WCC Items**

Fish Passage Study in Catchment - Frances Forsyth (Wildlands) has completed the study and the results have gone to Myfanwy Emeny. She has forwarded a copy to us, which shows many barriers to fish passage throughout. Myfanwy says the first priority is to rectify the barrier at the Kaiwharawhara/Korimako junction. She has a budget for this work within the next six months but is currently facing challenges with getting someone qualified to carry out the work. As well as clearing the slip they need to look at slope stability and fish passage through the tunnel itself. (See also under 'Kaiwharawhara Catchment Study' on p.4). **Myfanwy Emeny**

Ngaio Gorge Road Strengthening - The area below the recently strengthened section opposite #51 Ngaio Gorge Rd has been planted.

The next area to be strengthened is opposite the section at 123 Ngaio Gorge Road (above driveway to debris trap). Commencement will be some time in 2017.

Damaged Gabion upstream of Debris Trap - High stream flow in a September storm caused two rock gabions to fall into the stream. WCC have employed an engineer from Tonkin and Taylor to propose remedial options (if any), following a site assessment. A third gabion has started slumping. **David Halliday/Tim Harkness**

Bridge 3 Foundation Undermining - Floods in November washed away the stream bank at the bridge, exposing the foundations. The bridge is now unstable and has been closed. David Halliday of WCC, in consultation with TPG, is organising a replacement bridge and new track upstream. The stream banks are less prone to erosion there. **David Halliday**

131 Silverstream Rd Development Siltation - The earthworks for the new housing development at the head of the Silverstream valley is causing serious siltation in the Korimako Stream whenever it rains. The measures employed to prevent sediment and silty run-off into the stream are not working. This has been taken up with WCC and GW by TPG in conjunction with Andrew McLellan and Kelvin Hastie of Crofton Downs. **TPG monitoring continuing**

Park Brochures - Tim Harkness advises that the further supply requested by TPG is coming. **Tim Harkness**

Stream Bank Retaining Wall - David Halliday is investigating installation of a stream bank retaining wall to protect the track just downstream of Wightwick's Field. **David Halliday**

## **Pest Plant Control**

Following a park walk-through by Illona Keenan, Peter Reimann and contractors on 2 February, tradescantia control will be on steep areas above and below the original forest remnant (with some abseiling) and a patch below Waikowhai Street. WCC will also work on climbing asparagus below Oban Street, OMB on the road reserve above Ngaio Gorge Road and a patch of Japanese honeysuckle above the Kaiwharawhara Stream bank. **Illona Keenan**

TPG continue with manual control of tradescantia, OMB, Himalayan balsam, karaka seedlings, sycamore, bindweed and buddleia by individuals, working bees and corporate groups. **TPG**

## **Nursery/Planting Update.**

Planting total last year = 1,345.

Peter Reimann has ordered plants for 2017 from the WCC community planting list, which is the same as the 2016 list. It is expected that most of the 500 will go into 57 Kaiwharawhara Rd (down from the Living Room shop). There are several hundred home nursery plants for park infill. **Peter Reimann**

## **Animal Pest Control**

Bait station and mustelid trap servicing continues. Trap scores (revised) since 2008:145 rats, 17 stoats (5 may have been weasels), 17 hedgehogs.

Map revision is to be completed (some inaccuracies in lower Kaiwharawhara). It is important that the WCC and GW maps are consistent for bait station, trap and track locations. **WCC/GW**

Due to continued problems of bait spillage from the bait station entrances for free-range dogs, all bait stations have been converted by GW to use block bait instead of pellets. They had to reposition a few stations for bait accessibility.

This conversion means the bait stations no longer target possums - WCC think there is low risk of possums due to almost no evidence over the last 10 years and control has been expanded into areas of the skyline hills to the west. TPG will look for signs of possum activity into the future. **TPG pest animal team**

Access to Norway rats (poor climbers) remains - Illona Keenan has suggested either Protecta ground bait stations or some Goodnature A24 traps for trial below Oban Street. **Illona Keenan, Barry Durrant**

## **Park Access from Oban St and Kaiwharawhara Stream Bridge**

The residents' survey and report is complete. It has been copied to the two owners of the properties that the legal right of way goes between (112 and 114 Oban St) and will be made publically available.

**HPPA/WRA/TPG.**

HPPA and WRA committees will discuss the letter drafted by TPG/WRA commenting on issues raised by the survey, with the aim of sending this to accompany the survey report to Tim Harkness. Further distribution of the letter and survey to others in WCC and elsewhere will be agreed with Tim Harkness. **HPPA/WRA**

## **Lower Kaiwharawhara Stream and Estuary/Reclamation**

57 Kaiwharawhara Road Clean-up - Initial clean-up and rubbish removal by TPG, Conservation Volunteers and WCC is complete. A small area of grasses next to the footpath have been planted. Tim Harkness advises that weed spraying should hopefully happen between now and May. Planting/mulching will then follow. **Tim Harkness**

Sanctuary to Sea Walkway - Despite TPG's advocacy, WCC's have no plans to extend this beyond the magazine building ruin. Frances Lee will draft an email for WCC/GW requesting they pursue this, given the opportunity afforded by the Kaiwharawhara Point development work. Current indirect foot access is via Hutt Road and the ferry terminal. **Frances Lee**

Kaiwharawhara Point - Due to port damage from the November earthquake CentrePort advise that the Kaiwharawhara Point development is on hold for the immediate future. CentrePort's Board have also not yet approved the development.

## **Submissions**

122 Churchill Drive BUPA Aged Care Home - This is a limited notification proposal and TPG was not considered an 'affected party' by WCC. However, WCC have advised that TPG while not able to make a formal submission, is welcome to send comments. Accordingly, TPG have expressed concerns to WCC about potential effects on the streams from silty run-off during earthworks. After attending a community meeting, including Cr Andy Foster, TPG is liaising with those on the affected parties list and has sent the comments to them for possible inclusion in their submissions.

131 Silverstream Road Development - A stormwater detention dam is intended to control fast stormwater run-off and sediment/silt into the Silverstream. Consulting engineers Cardno have carried out a stormwater assessment showing that the effect from run-off will be substantially neutral. TPG will monitor progress during housing construction, advocating for permeable surfaces, plenty of tree planting and other stormwater slowing provisions, particularly with possibly more extreme weather due to climate change. **TPG**

### **Finance**

Payment to Peter Reimann of \$27.96 for potting mix approved. This comes out of the \$25 donated by Dorothy Douglass. The potting mix is being used for 'potting-on' of grasses from WCC's surplus seed trays and home nursery propagation. Many of these have already been planted.

The bank balance at 4 January was \$1,485.57. This includes the \$1,000 'gift' money, being kept aside for initial Oban St track expenses.

### **Other**

Kaiwharawhara Catchment Study - Danielle Shanahan of Zealandia advises that they are considering a whole-of-catchment waterway improvement effort (allowing fish and eel migration) in conjunction with perch eradication in the lower reservoir. TPG has signified that they would be keen to participate. Cr Diane Calvert is also keen to help sponsor this project. Pascale Michel of Zealandia is arranging a meeting in mid-February, involving Frances Lee/Peter Reimann and WCC's Myfanwy Emeny (see also under 'Fish Passage Study in Catchment' under 'WCC items' above).

Groups in Park - Thanks to Conservation Volunteers for again helping with weed clean-up. The magazine building ruin was used as a backdrop for a film production.

Parks Week - TPG participation will be at the working bee on 5 March 2017.

Wadestown Fair - TPG will have a stand at the fair on Saturday 11 March. **Peter Reimann**

GW Natural Hazards Management Strategy - Although missing the closing date for submissions (18 November 2016) Peter Reimann has now perused the Strategy to see if it has any relevance to TPG. It appears to adequately cover the aspects of risks, methodologies, education, research, collaboration, information bases, via a steering group. It lists coastal hazards, flooding, earthquake, wind, lightning, landslip, fire, drought and snow/hail.
