Environmental Projects

Minutes

The minutes of the 150th meeting, held on 7 December 2010, were confirmed.

WCC Items

<u>Seat on Railway Land</u> - It is expected that the seat would be installed early in 2011. Frances Lee has now asked WCC to proceed.

A seat "unveiling" ceremony will be held, where the contributing parties could be acknowledged. Ontrack is also to be invited, as the seat is on land leased from them. Frances Lee will ask Barry Durrant about the Wadestown Residents Association donation. *Frances Lee*

Ngaio Gorge Road Strengthening Restoration - Peter Reimann has written to Scott Kirkland (WCC) to organise cutting/poisoning the buddleia/willows/weeds on the strengthened sites, prior to planting later in the year (see previous minutes). In Scott's absence, Allan Moul from WCC Infrastructure is following this up.

Scott Kirkland/Allan Moul

<u>Poplar Trees below Crofton Downs Station</u> - WCC planted these some years ago as a temporary measure for slope stabilisation. TPG has written to WCC suggesting removal of the poplars, before they become too big. Joby Mills has so far been unable to speak to anyone in Ontrack to see if they are happy for these to be removed now. **Joby Mills**

<u>TransPower Pylon Foundation Upgrade</u> - The pylon foundation next to the Northern Walkway below Trelissick Crescent is to be upgraded. Joby Mills has met TransPower on site. There should be no significant effects. A date for the work (planned for March) is to be advised. **Joby Mills**

<u>Liquid Fuel Pipeline Upgrade (Tanks off Kaiwharawhara Road down to the Ferry Terminal)</u> - Joby Mills has discussed the work with Exxon Mobil and Downer EDI and is waiting for a copy of their specification. He has also contacted the Body Shop, as their streamside plantings will be affected. Joby will provide TPG with a copy of the specification. *Joby Mills*

Once the specification is received, Frances Lee will advise Leigh Bull/Boyden Evans of Boffa Miskell, as this traverses some of the area covered by the Kaiwharawhara estuary/reclamation study they are doing.

<u>Track Erosion by Stream below Wightwick's Field</u> - The track has been excavated to temporarily remove the hazard, but a more permanent measure such as a gabion, may be required in the future to protect the stream bank from erosion

<u>Date for 500 Trees Delivery</u> - Delivery early in autumn is preferred to give the plants a chance to establish themselves before winter and for organising a corporate group for planting. Joby Mills will advise date/time for delivery opp #19 Trelissick Cres, preferably to coincide with a working bee date (eg AM Tuesdays 15/3, 12/4, 10/5, 21/6). **Joby Mills**

<u>Debris Trap/Fish Survey</u> - In Alton Perrie's (GW) email to Amber Bill 15-12-09 (via Joby Mill's email 20-1-10) it was suggested that a fish survey should be carried out early in 2010 upstream of the debris trap to ensure fish are able to negotiate the debris trap. Peter Reimann will follow this up with Amber Bill **Peter Reimann**

<u>Flax Yellow Leaf Disease</u> - Peter Reimann accompanied Myfanwy Emeny, Nicky Oliver Smith and her offsider around the park to survey the extent and effects of the flax yellow leaf disease. There is no remedy. BNZ Closed for Good Volunteer Day - TPG has not received a response to the application for weeding/mulching on the park side of the carpark half-way up Ngaio Gorge Road in March. Peter Reimann will follow up. **Peter Reimann**

TPG Five-Year Plan - Following a meeting with Frances Lee, Peter Reimann will update the Plan (May 2009) Peter Reimann

<u>Signage Upgrading</u> - Joby Mills is upgrading northern walkway signage external to the park. After this he will upgrade bollards/pictograms in the park. He also has 3 pictograms for bollards for TPG restoration sites. One is for Marilyn Hester's "flood plain" site. The other sites suggested are below Hanover Street and at the gorse-cleared area below Trelissick Crescent. Joby will contact Peter Reimann to agree on locations for these. **Joby Mills**

<u>Brochure Holder</u> - Joby Mills will install a brochure holder at the map-board by bridge 6. TPG will then keep this topped up. **Joby Mills**

<u>Encroachments</u> - TPG is grateful for the removal of the upper two garages on Ngaio Gorge Road. Frances will contact WCC to see if the garages further down Ngaio Gorge Road can be removed (if they are not being used for vehicles). *Frances Lee*

<u>Stormwater</u> - Following the WCC resource consent application to GW for stormwater discharges in the harbour and subsequent submissions/meetings/discussions, there is a proposal to form consultative community groups covering stormwater and catchment management. TPG have had longstanding concerns with the effects of fast run-off, sedimentation and pollution on the streams in the park, but it is thought a wider local interest group such as NPA could more effectively be involved in the above consultative groups. Frances Lee is discussing this with NPA. *Frances Lee*

"Meet the Mayor and Councillors" - Frances Lee will apply to be included in one of the three group discussions on Tuesday 1 March. The suggestion is to discuss stormwater concerns and lax monitoring of resource consents. *Frances Lee*

"Branch Out" - Peter Reimann commented favourably on the e-version of WCC's "Branch Out" publication.

Apartments around Crofton Downs Station - Effects on the Park - TPG will need to keep an eye on any resource consents and work in connection with the idea of building apartments around Crofton Downs station Other WCC Issues - Joby Mills has dealt with: the dead willow impaled onto bridge 5, the printing of 300 TPG working bee pamphlets and the campervan parked long-term on Ngaio Gorge Road carpark - thank you Joby.

GW Items

Weed Spraying Update

Large-scale spraying of tradescantia/honeysuckle - Justin McCarthy has advised that the contractor will start this month *Megan Banks/Justin McCarthy*

Reparation spraying of blackberry on railway land by Dave Williams - Kill very effective, which will allow planting from early April. **P. Reimann**

<u>Take Care Fund</u> - Robyn Smith has organised some follow-up spraying for Mark McAlpine in February (see details in last minutes). TPG will do further manual removal of these areas as necessary. *Mark McAlpine/Peter Reimann*

[The next year of the funding commences on 1 July 2011, for further spraying by Mark McAlpine and home nursery requirements (to be advised). Robyn Smith suggested applying in February for an increase in funding to, say, \$2,000 per year, to allow more comprehensive follow up spraying. (There are 2 more years of funding to go, currently at \$1,500 per year).] **Peter Reimann**

Honda TreeFund Delivery - Robyn Smith will advise delivery date/arrangements. Robyn Smith

Oban St Track

Animal Pest Control

Bait is still being emptied consistently from several bait stations – probably by rats. Since September 2008, 56 mustelids/rats and 5 hedgehogs have been caught in the 15 traps.

A rabbit night shoot is due this month when the weather is clear.

Project Kaiwharawhara

Frances Lee is continuing to pursue the minutes of the last meeting with Myfanwy Emeny (drafted for her by Joby Mills). *Frances Lee*

Kaiwharawhara Estuary/Reclamation

WCC have agreed to extend the time frame of their grant for 6 months to end of April 2011. Boffa Miskell has provided an update of their tasks and programme to achieve completion of their draft report on the estuary by then. The draft will then be sent to interested parties for comment. Frances Lee is following up progress with them. *Frances Lee*

Frances Lee will be providing separate information (alongside the study) covering political/ownership aspects in connection with the estuary and surrounds. Edgar Clark, who has had a longstanding interest in the area, is willing to assist her This was noted by TPG. *Frances Lee*

NZ Transport Agency is commissioning a study of options for the motorway extension in the vicinity and will keep TPG informed of progress/upshot *Frances Lee*

Interislander have promised to periodically remove rubbish down to the estuary from the north end of the vehicle marshalling area, also restore and move forward the timber bulwarks protecting the plantings and mapboard. TPG will need to schedule a visit for weeding and to check that Interislander staff have been doing as promised. **Peter Reimann**
