Talk

Nyree Fea, who is doing a PhD at Victoria University, gave a short presentation about her intensive monitoring of tui and fantails in Wellington City to study outcomes in relation to pest-mammal abundance. She also showed two videos at the end: one of fantails feeding chicks on the nest and one with a rat leaving that nest after eating a chick. She wants us to look for tui and fantail nests so that she can add them to her monitoring.

Minutes

The minutes of the 172nd meeting, held on 25 May 2015, were confirmed.

WCC Items

<u>Park Rangers</u> - WCC has employed a 5th Park Ranger. In three weeks Tim Harkness will take over from Matt Robertson, to cover Trelissick Park.

<u>Fish Passage Study</u> - Frances Forsyth (Wildlands) will soon be starting this study. Peter Reimann will contact her in a few weeks for an update. *Frances Forsyth/Peter Reimann*

<u>131 Silverstream Road, Crofton Downs Development</u> – Following preliminary land clearance, a consent application for earthworks has been lodged. The proposed earthworks for 119 sites are extensive and could affect the streams in Trelissick Park. No advice has yet been received on whether the consent will be on a notified or non-notified basis. Even if the earthworks comply with the District Plan so do not require notification, TPG say that all interested parties should be kept informed by WCC. TPG has previously registered as an interested party. Meanwhile, a developer has been advertising on Trade Me to gauge interest of building companies, subject to resource consent. Local residents, led by Andrew McLellan in conjunction with NCDRA, have been watching developments. Olaf John questioned whether GW would allow undergrounding the stream for 900 m. *Peter Reimann*

<u>Historic Walls</u> - Frances Lee will contact Buzz Graham about refurbishment of the revetment wall below the railway tunnel beside the Silverstream. *Frances Lee*

<u>Ngaio Gorge Road Strengthening</u> - The earthquake strengthening of the top section of Ngaio Gorge Road is back on the agenda for the 2015/16 budget, details to be advised. *Faiz Tawfeek/Rebecca Ramsay/Tim Harkness*

<u>Sewer Leak</u> - The sewer pipe beside the Korimako Stream at the upper end of the park completely ruptured due to a foundation collapse. WW have done a temporary repair. A permanent repair is to follow. This will involve a new 30 m section placed further back from the stream than currently. WW (Malcolm Giles), WCC (Rebecca Ramsay) and TPG are to meet on site beforehand. *Matt Robertson/Tim Harkness*

The health warning signs at entrances will be removed. Matt Robertson

<u>Park Brochures</u> - WCC are supplying 1,000 park brochures for TPG to continue topping up the entrance brochure holders. *Matt Robertson*

Longfin Eel Sign - Now installed just upstream of the debris trap. Thanks Myfanwy Emeny, WCC and contractor Tony Stoddard (who did the art-work).

Pest Plant Control

<u>Tradescantia</u> - Illona Keenan is to confirm that the WCC contractor has completed spraying areas on the fringes of the original forest remnant and in the valley below Hanover Street. *Illona Keenan*

TPG is continuing with manual removal of tradescantia in smaller areas bordering the original forest remnant. BNZ are to remove more upstream of the Northern Walkway bridge on their 'Closed for Good Day' **TPG**

<u>Climbing asparagus</u> - Control of the large infestations of climbing asparagus in the park below Oban Street does not appear to have started (WCC contractor (NZBL). Jonathan Anderson (WCC) has found more within the original forest remnant. Illona Keenan to provide update. *Illona Keenan*

Sycamore - Bill Hester has been tackling sycamore, conspicuous with autumn leaves.

<u>Follow up weed control on railway corridor</u> - Treescape have funding for 3 days work. Illona Keenan to provide update.*_IIIona Keenan*.

Nursery/Planting Update

423 have been planted so far this year, including all but around 20 of the 350 from WCC. Most of the epiphytes from WCC have been placed in the forks of old trees - locations mapped. 33 of home nursery kahikatea have been given to others, 60 remaining for F & B.

Animal Pest Control

Bait station and mustelid trap servicing continues. Trap scores since Sept 2008:130 rats,15 stoats, 17 hedgehogs. One dead possum was found - the first evidence of possums for more than 10 years.

Park Access from Oban St

After a meeting between WCC and TPG and subsequent correspondence, Amber Bill (WCC) confirmed the owners of 112/114 prefer access to the legal right of way between 112/114 by use of the formed path/steps under the car-deck of 112. She confirms that this is located on road reserve, so does not cross onto private property. Amber says "They would ideally like to be emailed prior to using the area so that all parties can avoid feeling uncomfortable, however I have been in touch to let them know you do not wish to contact them. Obviously they are disappointed, but realise it is a legal access way."

TPG would like the location of the legal right of way marked in some way, to ensure users do not trespass - Peter Reimann to discuss with Amber. *Amber Bill/Peter Reimann*

WCC will not agree on formalising access without a footbridge across the Kaiwharawhara Stream. Should TPG raise funding for a bridge (approx \$120K), WCC would provide project coordination. Amber advises wider consultation would be required, including residents of Oban Street.

Lower Kaiwharawhara Stream and Estuary/Reclamation

<u>Wellington Civic Trust</u> - The chairmanship has changed from Alan Smith to Toni Izzard and his deputy is Clive Anstey. They are planning to discuss with GW concerning more public involvement in the CentrePort master plan for the reclamation/estuary area.

New Bus Depot - In operation and approved perimeter fence plan with two gates received.

<u>57 Kaiwharawhara Road</u> - Matt Robertson has arranged for the WCC Tree Team to clean up the trees over the footpath - it is on their work schedule. The idea of a car park there has not been pursued.

<u>Sustainable Coastlines Project - Love Your Water Project</u> - Collaboration of riparian planting with Oliver Vetter of Sustainable Coastlines and Amanda Dobson of Enviroschools has commenced with a park walk-through and subsequently a working bee with IT firm Silverstripe, organised by Oliver.

<u>Health and Safety Workshop</u> - Peter Reimann attended an *In Safe Hands* workshop by Conservation Volunteers at Otari Wilton's Bush on 22 August. TPG health and safety provisions have been updated to incorporate provisions in the 'Toolkit' provided. <u>Water Quality Monitoring Station</u> - WW would like to install a monitoring station to monitor water quality in the Kaiwharawhara Stream. It would be in a steel box, above the ground. One location proposed is by the stream next to the manholes for sewer cleaning, near the end of the vehicle track upstream of the debris trap. However, there is a question of a power supply there. TPG suggested somewhere at the lower end of the park - unobtrusive, easy access, close to power supply and would 'catch' more pollution. A further issue is whether interpretive information would allay intrusiveness. Matt Robertson will discuss with WW and advise. *Matt Robertson*
