Minutes

The minutes of the 174th meeting, held on 24 November 2015, were confirmed.

WCC Items

<u>Fish Passage Study</u> - [Julia Williams advises that Frances Forsyth (Wildlands) has completed the study and the results have gone to Myfanwy Emeny, but the report is not yet written. There were a huge number of structures and the assessment will help WCC prioritise where to start with fish passage enhancement or removal of structures] *Frances Forsyth/Myfanwy Emeny*

<u>131 Silverstream Road, Crofton Downs Development</u> – The proposed earthworks for 119 sites are extensive and could affect the streams in Trelissick Park. WCC have advised that the earthworks will proceed on a non-notified basis. The associated land clearance does not need a consent. Local residents, led by Andrew McLellan in conjunction with NCDRA are monitoring for any down-stream effects.

Julia Williams advised that the stream will be day-lighted and moved to the northern side of the valley. Large stormwater pipes will assist detention of run-off during heavy rain.

<u>Ngaio Gorge Road Strengthening</u> - The wall opposite No. 51 is currently being earthquake strengthened. The top section of Ngaio Gorge Road is back on the agenda for the 2015/16 budget, details to be advised. *Faiz Tawfeek/Rebecca Ramsay/Tim Harkness*

Pest Plant Control

<u>Plans for next few months</u> - Illona Keenan, contractor Kaitiaki and Peter Reimann have been liaising on further control of tradescantia, climbing asparagus, Japanese honeysuckle, OMB and Asiatic knotweed. Illona has organised another contractor to tackle areas requiring abseiling. This will include one of the earthquake strengthened areas below upper Ngaio Gorge Road, to allow planting through the wire mesh in 2017. *Illona Keenan*

Barry Durrant is concerned about need for ongoing control of climbing asparagus below Oban Street. Peter Reimann will check with Illona Keenan that this is included. *Peter Reimann*

TPG continue with manual control of tradescantia, OMB, Himalayan balsam, karaka seedlings, bindweed and buddleia by individuals, working bees and corporate groups. *TPG*

A large group from Ministry of Primary Industries is visiting on Friday 4 March for a BYO picnic at the magazine building, followed by a weed sweep up the valley. Tim Harkness will provide a 'Superloo', black plastic and, if possible, some rakes and spare gloves. *Tim Harkness*

Nursery/Planting Update.

WCC plant list and order form for 2016 has been received and request for 475 submitted. Many of these will be for ground cover for recently sprayed areas on the slopes below Hanover Street near the stream, open areas in the Korimako valley, railway land above bridge 6 and at the two Ngaio Gorge Rd entrances.

Tim Harkness will check to see if at least some of these can be picked up early in May. Tim Harkness

Peter Reimann has about 130 more to supplement the above.

Animal Pest Control

Bait station and mustelid trap servicing continues. Trap scores to early February since Sept 2008:134 rats,15 stoats, 17 hedgehogs.

TPG think that a review of bait, bait stations and traps would help, in the light of research and experience over the years. *Illona Keenan*

Park Access from Oban St

Following a site meeting with Peter Reimann, Abseil Access have selected a site for a footbridge across the Kaiwharawhara Stream, just upstream of the debris trap. This will allow our long-sought connection to Oban Street. They will provide an estimate and drawing to allow applications for resource consents and funding.

Kate Sanders (nee Mackenzie) has offered to assist with the resource consent applications. She was involved with the park in 2006-7 (with GW, WCC and TPG) and now has her own business in Auckland which includes preparation of resource consent applications.

It is understood by TPG that WCC will organise and fund the track/signage/steps/any fencing from Oban Street past the houses.

Lower Kaiwharawhara Stream and Estuary/Reclamation

<u>57 Kaiwharawhara Road</u> - The area has just been cleared of trees to some distance back from the footpath. There is a possibility WCC may sell this at some time in the future. However, it is a weedy eyesore. It is linked with the Sanctuary to Sea Walkway and could be made into an attractive lunch spot for local workers and a 'stopover' for walkers with a seat beside the water – at very little cost. [Conservation Volunteers are willing to clean it up, but Tim Harkness advises this is subject to removal 'possessions' by a hoarder by 1 May and subsequently by WCC if necessary. Peter Reimann will follow this up in May]. *Peter Reimann*

<u>Estuary Clean-up</u> - Malcolm McDonald is organising this for the morning of Sunday 6 March. *Malcolm McDonald*

Submissions

<u>Input to WCC Annual Plan</u> - TPG requested more funding for pest control, better stormwater control (neutral effect from new developments), improved sewer maintenance, assistance with access provisions to the park from Oban Street, completion of the Sanctuary to Sea walkway, access to the Kaiwharawhara reclamation northern beach and cleaning up 57 Kaiwharawhara Road. The importance of the ecological corridor from the Kaiwharawhara estuary was stressed.
