Minutes

The minutes of the 177th meeting, held on 2 August 2016, were confirmed.

WCC Items

<u>Fish Passage Study</u> - Frances Forsyth (Wildlands) has completed the study and the results have gone to Myfanwy Emeny, who is looking at WCC prioritise and where to start with fish passage enhancement or removal of structures. Is this for the whole catchment down to the estuary? Timing and details to be advised. This has been outstanding for several months so Peter Reimann will check with Myfanwy Emeny. **Peter**

Ngaio Gorge Road Strengthening - The area below the recently strengthened section opposite #51 Ngaio Gorge Rd has been planted.

The next area to be strengthened is opposite the section at 123 Ngaio Gorge Road (above driveway to debris trap). Commencement will be some time in 2017.

<u>Water Quality Monitoring Station</u> - It now transpires that the monitoring station is the one installed a few months ago next to the vehicle track about 500 m upstream of the debris trap. This monitors waste water in the sewer system to help WW trace stormwater/sewer cross-connections. GW sample the Kaiwharawhara Stream monthly, but this is unlikely to 'catch' high pollution peaks. Monitoring for e-coli is a manual process, so continuous monitoring is not practicable.

<u>Damaged Gabion upstream of Debris Trap</u> - High stream flow in a September storm caused two rock gabions to fall into the stream. WCC have employed an engineer from Tonkin and Taylor to propose remedial options, following a site assessment. *David Halliday/Tim Harkness*

<u>Bins at Entrances</u> - Installation of bins the entrances that do not have them is due for completion by the end of the year. WCC will monitor usage and will remove them if they are not used or if dumping occurs around them.

Pest Plant Control

The steep areas around the original forest remnant will be included in abseil work 2016-17 by contractor NZBSL, also follow-up of climbing asparagus below Oban Street. *Illona Keenan*

TPG has identified further places for possible weed control by WCC's contractor. Update of WCC's projected work requested. *Illona Keenan*

TPG continue with manual control of tradescantia, OMB, Himalayan balsam, karaka seedlings, bindweed and buddleia by individuals, working bees and corporate groups. *TPG*

Nursery/Planting Update.

Planting total so far this year = about 1,250 (WCC, F & B and home nurseries). Main areas: entrances at Ngaio Gorge Rd, Hanover St and above Waikowhai St, streamside opposite magazine ruin, above debris trap, upstream and downstream of bridge 6, Trelissick Cres. verge, railway slope opposite Wightwick's Field, streamside below Waikowhai St, infill elsewhere.

Peter Reimann will order plants for 2017 from the WCC community planting list, which is the same as the 2016 list. It is expected that all 500 will go into 57 Kaiwharawhara Rd. There are several hundred home nursery plants for park infill which will be ready in 2017. **Peter Reimann**

Animal Pest Control

Bait station and mustelid trap servicing continues. Trap scores since 2008:145 rats,16 stoats, 17 hedgehogs.

The two self-resetting Goodnature A24 traps have only scored two catches, one being a mouse.

Map revision is to be completed (some inaccuracies in lower Kaiwharawhara). It is important that the WCC and GW maps are consistent for bait station, trap and track locations. **WCC/GW**

Due to continued problems of bait spillage from the bait station entrances for free-range dogs, all bait stations are being converted by GW to use block bait instead of pellets. They had to reposition a few stations for bait accessibility.

This conversion means the bait stations no longer target possums - WCC think there is low risk of possums due to almost no evidence over the last 10 years and control has been expanded into areas of the Skyline. TPG will look for signs of possum activity into the future. **TPG pest animal team**

Access to Norway rats (poor climbers) remains - WCC have suggested a ground bait station. TPG will advise comments. *Bill Hester/Peter Reimann*

Park Access from Oban St and Kaiwharawhara Stream Bridge

The residents' survey is due to start within the next 10 days. Jenny Lewis (WRA) will be meeting Elizabeth Knopf (HPPA) later this week to finalise arrangements [eg printing, circulation]. TPG is concerned about delays because of the approaching holiday period when residents might be absent.

It was suggested that tramping clubs should be included in the survey, with local WCC Councillors kept informed.

Lower Kaiwharawhara Stream and Estuary/Reclamation

<u>57 Kaiwharawhara Road Clean-up</u> - P. Reimann and Conservation Volunteers have completed an initial weed sweep. There is still much more weed clearing required. Peter Reimann will organise more volunteers and a TPG working bee. *Peter Reimann*

[After that: weed spraying, planting, mulching - Peter Reimann to organise in conjunction with Tim Harkness]. **Peter Reimann**

Tim Harkness advises that the owner of the land leased to the Living Room is not keen on extending the area he mows further into 57 Kaiwharawhara Rd.

<u>Sanctuary to Sea Walkway</u> - Despite TPG's advocacy, WCC's have no plans to extend this beyond the magazine building ruin. Frances Lee will draft an email for WCC/GW requesting they pursue this, given the opportunity afforded by the Kaiwharawhara Point development work. *Frances Lee*

<u>Kaiwharawhara Point</u> - At the Centreport environment committee meeting early in August, community representatives, Wellington Civic Trust and TPG, expressed concerns about lighting, noise, fencing, excavation/stability/bunding, landscaping. The non-notified resource consent has been approved by GW. If the project is approved by the CentrePort Board, the work could commence by the end of the year or early in 2017.

Hutt Road Bridge over Kaiwharawhara Stream - WCC is widening the cycle/foot path on the south side.

<u>131 Silverstream Road Development</u> - A stormwater detention dam will control fast stormwater run-off into the Silverstream. Peter Reimann will check the documentation to see whether there will be additional provisions, such as permeable surfaces, soakage areas or planting. *Peter Reimann*

Finance

Payment to Peter Reimann of \$158.62 for potting mix and fertiliser approved. With the previous \$74.76 approved at the last meeting, this now uses all the \$209 donation from Jade Stapleton's Samuel Marsden School's science project fundraising. The potting mix/fertiliser is being used for 'potting-on' of grasses from WCC's surplus seed trays and home nursery propagation. Many of these have already been planted. Peter Reimann to write to Jade Stapleton with update on how the funds were spent. *Peter Reimann*

The bank balance at 4 October was \$1,644.19. This includes the \$1,000 'gift' money, being kept aside for initial Oban St track expenses.

Other

<u>Perch in Zealandia Lower Reservoir</u> - Zealandia are considering getting rid of the 20,000 - 30,000 perch in the lower reservoir. As it is part of a wider tributary, they think this could help coordinate a whole-of-catchment waterway improvement effort (allowing fish and eel migration). TPG has signified that they would be keen to participate. This could be a trigger to rejuvenate 'Project Kaiwharawhara', involving all interested parties.

<u>Groups in Park</u> - Thanks to Conservation Volunteers, BNZ 'Closed for Good' Day, Academic Programs International (Victoria University). A large orienteering group used the park in September and a school group visited to pick up rubbish.

Parks Week - TPG participation will be at the working bee on 5 March 2017.

<u>GW Natural Hazards Management Strategy</u> - Peter Reimann will peruse to see if it has any relevance to TPG. **Peter Reimann**
