Minutes

The minutes of the 179th meeting, held on 7 February 2017, were confirmed.

WCC Items

<u>Fish Passage Improvement in Catchment</u> - Myfanwy Emeny says the first priority is to rectify the barrier at the Kaiwharawhara/Korimako junction. She has a budget for this work but is currently facing challenges with getting someone qualified to carry out the work. As well as clearing the slip they need to look at slope stability and fish passage through the tunnel itself. *Myfanwy Emeny*

<u>Ngaio Gorge Road Strengthening</u> - The area opposite the section at 123 Ngaio Gorge Road (above driveway to debris trap) is currently being strengthened. Planting will be needed when the work is finished. *Tim Harkness*

<u>Damaged Gabion upstream of Debris Trap</u> - High stream flow in a September storm caused two rock gabions to fall into the stream. WCC have employed an engineer from Tonkin and Taylor to propose remedial options (if any), following a site assessment. A third gabion has started slumping. Currently it is a case of 'wait and see'. **David Halliday/Tim Harkness**

<u>Bridge 3 Replacement</u> - Following foundation undermining, David Halliday of WCC, is organising a replacement bridge and new track upstream. Design finalisation and resource consenting is in progress but will take up to three months. *David Halliday*

<u>131 Silverstream Rd Development Siltation</u> - The earthworks for the new housing development at the head of the Siverstream valley is causing serious siltation in the Korimako Stream whenever it rains. This has been taken up with WCC and GW by TPG in conjunction with Andrew McLellan and Kelvin Hastie of Crofton Downs. WCC/GW have investigated and are taking remedial action. *Monitoring by TPG continuing*

Korimako Stream Bank Gabions- David Halliday has organised gabions to protect the track just downstream of Wightwick's Field and to install the gabions at bridge 2.

<u>Predator Free Ngaio</u> - WCC is assisting Predator Free Ngaio with resources and mapping. Traps for rats are being installed in various parts of the suburb.

<u>WCC Changes</u> - Myfanwy Emeny is taking over Amber Bill's position as Open Spaces and Parks Manager. David Sole is moving back to his botanic gardens management role. Myfanwy's position as Team Leader Urban Ecology is being advertised.

Pest Plant Control

Some tradescantia control has been carried out on steep areas below the original forest remnant. The contractor was late starting and rain has impeded progress. Illona Keenan has been asked to confirm the status of the other areas identified during the 2 February walk-through (see also previous meeting minutes). *Illona Keenan*

TPG continue with manual control of tradescantia, OMB, Himalayan balsam, karaka seedlings, sycamore, bindweed and buddleia by individuals, working bees and corporate groups. *TPG*

Nursery/Planting Update.

Planting so far this year = 247. 500 plants were delivered from WCC on Friday 5 May. Many are destined for 57 Kaiwharawhara Rd (down from the Living Room shop).

Animal Pest Control

<u>Trap Scores</u> - Bait station and mustelid trap servicing continues. Trap scores since 2008:154 rats,17 stoats (5 may have been weasels), 17 hedgehogs.

<u>A24 Traps</u> - Three more self-resetting Goodnature A24 traps have been deployed, to bring the total up to 5, to also target Norway rats (poor climbers). TPG will advise locations (two recently relocated). **TPG**.

<u>New 'Baitsafe' Stations for Possums</u> - Conversion of bait station to block bait means the bait stations no longer target possums, so GW have installed 20 'Baitsafe' stations throughout the Park. The possum actuates a lever to access the bait. GW will service these.

<u>Map Revision</u> - Map revision is to be completed (some inaccuracies in lower Kaiwharawhara). It is important that the WCC and GW maps are consistent for bait station, trap and track locations. **WCC/GW**

<u>Chew Card Markers</u> - TPG have suggested they remove the chew card markers (trials finished a couple of years ago) - WCC agreement awaited. *Tim Harkness*

Park Access from Oban St and Kaiwharawhara Stream Bridge

The residents' survey and report is complete. The report has been copied to the two owners of the properties that the legal right of way goes between (112 and 114 Oban St). The survey report and TPG/HPPA/WRA recommendations have been sent to Tim Harkness.

Three alternative bridge options have been presented to WCC, in view of flood damage concern about the location originally proposed by Abseil Access. A fourth option was also noted at the meeting.

With the aim of getting conditional agreement to proceed with the project, Peter Reimann will draft proposed next steps to be followed and cleared including:

- Entrance via road reserve, fencing/landscaping, discussion with 112/114 owners, funding (including from WCC Long-Term Plan)

- Footbridge options including track access and any stream bank/foundation issues. Comments from Abseil Access.

This will be circulated for comment. Peter Reimann

Elizabeth Knopf will make the survey report publically available and send a copy of the TPG/HPPA/WRA recommendations to the owners of 112/114 Oban Street. *Elizabeth Knopf*

Lower Kaiwharawhara Stream and Estuary/Reclamation

<u>57 Kaiwharawhara Road Clean-up</u> - Weed control and mulching is almost complete. Some grasses have been planted in the front, shrubs further back and mostly karamu and lemonwood above the stream bank. Conservation Volunteers are coming on 24 May to complete the planting/mulching.

Completion of planting and mulching will now follow, using many of the plants from the WCC allocation. TPG

<u>Sanctuary to Sea Walkway</u> - TPG have proposed to WCC (see email list 12th item below for recipients) an update of their website to also describe the footpath/road section below the Park down to the harbour via Kaiwharawhara Road, Hutt Road, pedestrian ramp and footpath at the Aotea Quay bridge, then past the ferry terminal. The website description should start at Zealandia, to be consistent with the title of the track. Appropriate signage would be needed. *Tim Harkness*

<u>Kaiwharawhara Point</u> - Due to port damage from the November earthquake CentrePort advise that the Kaiwharawhara Point development is on hold for the immediate future.

Frances Lee has prepared a proposal to GW, as the majority owner of CentrePort, to make the Kaiwharawhara estuary and Kaiwharawhara Point shoreline (including the northern beach) accessible to the public. The text has been agreed with representatives of HPPA, Wellington Recreational Marine Fishers Association and Khandallh residents - together with TPG - all original members of the Kaiwharawhara Reclamation Working Group and all current members of CentrePort's Environmental Consultative Committee. After sending to GW the proposal will be circulated to a range of interested parties including WCC. *Frances Lee*

Submissions

<u>122 Churchill Drive BUPA Aged Care Home</u> - This is a limited notification proposal and TPG was not considered an 'affected party' by WCC. However, TPG have expressed concerns to WCC about potential effects on the streams from silty run-off during earthworks. The resource consent application, affected party submissions and comments are with WCC for their consideration. **WCC**

DOC's Draft Wellington Conservation Management Strategy (CMS) - TPG had no comments.

WCC Annual Plan - TPG are aiming to lodge a submission (closing shortly). Frances Lee/Peter Reimann
