Minutes

The minutes of the 185th meeting, held on 21 August, were confirmed.

Talk by Amanda Valois

Amanda Valois of NIWA gave an outline of the work she is doing on rubbish in the Kaiwharawhara catchment. She is looking at this as their model catchment, particularly because the sources of rubbish are quite varied and well documented. It is also small enough to get a complete assessment of rubbish.

Zealandia's Sanctuary to the Sea Project fits in nicely with these aims and she hopes to help co-develop a plan for reducing rubbish and eliminate waste export to the sea (as much as possible). This model could be applied to other catchments across NZ.

Amanda came to talk about our ideas, our vision for a rubbish-free catchment and any way NIWA can support us.

In a recent email, TPG summarised sources and types of our rubbish and the arrangements for WCC to pick up collected rubbish from our 'dump' site below Trelissick Crescent. TPG collect rubbish at bi-monthly working bees and during other visits to the Park. TPG had a volunteer rubbish collector (including the streams). It is hoped to interest another volunteer when she visits next Sunday.

Peter Reimann will add Amanda to the working bee email list (next one on Sunday 2 December) and advise the outcome of the above volunteer visit. *Peter Reimann*

WCC Items

<u>Fish Passage Improvement in Catchment</u> - WCC's Daniela Biaggio has provided an assessment report by ATS Environmental. However, the conclusions need clarification. There is still concern about the exit of the Silverstream tunnel under the railway line below Crofton Downs station and other barriers in the catchment. Peter Reimann will contact Daniela. *Peter Reimann*.

Ngaio Gorge Road Slips - No updates on remediation. Cr Diane Calvert is following this.

<u>Forest Remnant Track Maintenance</u> - There is a need for minor re-benching along the Forest Remnant Track to improve safety. TPG volunteers or a corporate group could do much of this. However, retaining work to restore collapsed track sections above slopes would need to be done by WCC. *Peter Reimann*

<u>Track Upgrade from Waikowhai Street Entrance</u> - Park users have been very pleased with the improvement - thanks to Tim Harkness and contractor.

Park Brochures - More to be requested from WCC, for brochure holders. Peter Reimann

<u>Working Bee Pamphlet</u> - Programme to be worked out for 2019 and pamphlets to be requested from WCC. *Peter Reimann*

<u>Plant Order for 2019</u> - Anita Benbrook says we can order up to 1,000 plants, as long as it is in two lots of 500. Due to the extent of the Trelissick Crescent verge and the large bare slope below the eastern end of the Forest Remnant track, it was agreed that we would order 1,000. *Peter Reimann*

<u>New WCC Ranger</u> - Advice on who will be the new Park Ranger covering Trelissick Park is awaited. *Myfanwy Emeny*

Pest Plant Control

<u>Weed Control Planning</u> - On 19 July Illona Keenan (WCC) said: "We are going through a tender process for the next 5 years of weed control at the moment so I will be in touch when we have the outcome of that to ensure the successful contractors know all the ins and outs of our requirements and how to work with you all." TPG is looking forward to the outcome and how to assist. *Illona Keenan*

<u>Tradescantia below Hanover Street</u> - A group of Scouts cleared some the tradescantia from the lower slopes adjoining the Northern Walkway down from the Hanover Street entrance on 22 September. Another group from Raroa Intermediate School is coming to do some more on 10 December. Illona Keenan says the WCC contractor can then clean up the rest of it. *Illona Keenan/Peter Reimann*

<u>Climbing Asparagus below Oban Street</u> - NZ Biosecurity Ltd has tackled climbing asparagus on the slopes below Oban Street - needs ongoing work *Illona Keenan*

<u>OMB Gall Mite</u> - Use of this gall mite has just been approved. Megan Banks of GW advises that this will be introduced into the Wellington region in 2020. *Megan Banks*

TPG continue with manual control of tradescantia, OMB, Himalayan balsam, karaka seedlings, sycamore, bindweed and buddleia by individuals, working bees, Conservation Volunteers and corporate groups. *TPG*

Nursery/Planting Update.

Just over 1,000 have been planted this year. Sources: WCC, F & B and Peter Reimann's nurseries, also some surplus northern rata from Conservation Volunteers. These included many podocarps and species to improve the diversity: large leaved milk tree, pukatea, kaikomako, totara, matai, rimu.

TPG are planting densely growing species along the Trelissick Crescent verge to discourage dumping of rubbish and garden waste. More needed (to be included in 2019 plant order from WCC). Marilyn Hester and Peter Reimann are also trying to propagate Hebe parviflora from cuttings for this purpose. *Peter Reimann*

Animal Pest Control

Trap Scores - Trap scores since 2008: 238 rats/mice,17 stoats/weasels, 17 hedgehogs.

<u>Rabbits</u> - More this year and some plant damage. Protection is being employed - supplied by WCC. They do not seem to have penetrated the Kaiwharawhara valley.

<u>Map Revision</u> - Map revisions showing bait stations and traps locations are under discussion between TPG's Bill Hester and GW's Bruce Brewer. *Bruce Brewer/Bill Hester*

Park Access from Oban St

The WCC survey was advertised early in October and closed on 29 October.

WCC's Myfanwy Emeny/Catherine Taylor are writing a report, with recommendations for a December Council meeting. They will meet with us before the report is submitted. WCC decision on the project will then be advised. *Myfanwy Emeny/Catherine Taylor*

Lower Kaiwharawhara Stream and Estuary/Reclamation

<u>Sanctuary to Sea Walkway</u> - WCC have still not changed the description on the website, so that it commences at the 'Sanctuary' and proceeds to the lower end of the Trelissick Park *Tim Park*

<u>Kaiwharawhara Estuary and Point</u> - Updates on the reclamation and CentrePort's long-term plan will be provided by CentrePort's William Woods at the talk at the Sanctuary to Sea meeting at Zealandia on 27th November and at the upcoming CentrePort Environmental Committee meeting. *Frances Lee*
