Minutes

The minutes of the 189th meeting, held on 20 August, were confirmed.

Discussion on Natural Bush Areas and Special Landscapes in District Plan Review

Dr Onur Oktem and Joshua Patterson from WCC's *City Design and Place Planning* outlined their work on the above, described in the booklet *Backyard Tāonga*. The District Plan is associated with the Resource Management Act. So far they have looked at 169 sites (public land) and contacted 1,700 land owners. The split between the two is roughly 50/50. Many of the land owners have responded. They are investigating rarity, threatened areas, diversity, connectivity and significance to Tangata Whenua. The results will be fed into the Draft District Plan Review, which will be looking at how to accommodate population/housing increase in conjunction with preserving natural bush areas and special landscapes (due mid-2020). *TPG submission mid-2020*)

Matters arising:

<u>Kilmarston development above Ngaio</u> - TPG is concerned about downstream effects and NCDRA is concerned about environmental and other effects. The application is currently on 'suspend' - see also under "Submissions" below.

<u>17-Unit Development at 128 Trelissick Crescent</u> - TPG is concerned about destruction of original forest remnant and downstream effects. The application is currently on 'suspend'. Honur Oktem says there are hurdles with this application - see also under "Submissions" below.

Railway land adjoining Trelissick Park - TPG has long been concerned about pest weeds from railway land and the effects on the Park. TPG suggests that this land be considered in the Plan review. *Onur Oktem* Some of their land in the valleys is leased to WCC [TPG treat this as part of the Park and also work on other parts of railway land in the valleys].

<u>Kaiwharawhara Estuary and Kaiwharwhara Point</u> - WCC is involved with GW's Whaitua Committee and Onur Oktem sits in on meetings to monitor effects on the District Plan. TPG suggests she comes to the next *Sanctuary to Sea* meeting, which will include discussion on this area [Zealandia, 5.30 PM, 3rd December]. *Onur Oktem*

<u>WCC's Water Sensitive Urban Design (WSUD)</u> - TPG has for many years been advocating for this to be a mandatory requirement in all new land developments, including infill housing. The Kaiwharawhara catchment is large and the streams in the Park suffer from fast stormwater run-off from hard surfaces. TPG suggests this

be included in the Plan Review. Onur Oktem

<u>Contact for Conservation Volunteers NZ</u> - CVNZ have planted large areas at Mt Victoria and possibly this area could be considered in the Plan review. Peter Reimann [has given] Onur Oktem contact details.

Ngaio Gorge Road Slips and Parking - Slips: see below under "WCC Items". Parking: This has been an ongoing problem at the lower entrance - [Peter Reimann to take up with WCC **Peter Reimann**]

WCC Items

<u>Fish Passage Improvement in Catchment</u> - TPG has advocated for more funding in its submission of 8 May on WCC's Annual Plan. *Michele Frank*

<u>Ngaio Gorge Road Slips</u> - Geotechnical investigations, topographical surveys and stabilisation work have been completed for WCC. Designs are being finalised and if consent is given, construction should be underway in November. The work should be complete by October 2020.

<u>Earthquake Strengthening below Upper Ngaio Gorge Road</u> - The existing wall below the upper end of Ngaio Gorge Road is undermined and the slope below is moving. A 'batter slope' below the road for earthquake strengthening is proposed by WCC's contractor WSP-Opus. This would encroach onto the original forest remnant area - environmentally destructive. A large tītoki tree would go, as well as the large pine, macrocarpa and eucalypt trees.

Considering the cost of removing the large trees and the multiple land ownership in the area, TPG is hoping that WSP-Opus, after further investigation, will find that the alternative of a new wall with deep piles is viable instead. Peter Reimann will ask WSP-Opus for an update on what they intend to do. He will keep WCC's Onur Oktem in the loop. *Peter Reimann*

If the batter slope option is finally decided, TPG will be removing some valuable seedlings from the area. The slope would be re-planted afterwards.

Debris Trap Clearance - The large tree trunks and debris heap have at last been removed by WW.

<u>Rubbish Dumping Below Trelissick Crescent</u> - Bill Hester discovered household effects (eg mattresses) dumped below Trelissick Crescent and contacted Adam Groenewegen for removal.

Pest Plant Control

<u>WCC Pest Plant Control by WCC/Contractor</u> - TPG's submission of 8 May on the WCC Annual Plan advocated for increase in funding. TPG is very grateful for the extensive weed control work carried out by WCC's contractor. Kaitiaki o Ngahere, with support from WCC's Illona Keenan.

Kaitiaki/WCC are planning the next spray season now, Peter Reimann sent suggestions to Illona for inclusion in planning decisions in an email of 25 August.

Kaitiaki have just completed follow-up control of tradescantia on the lower forested slopes below Hanover Street.

<u>Control by TPG</u> - TPG continue with manual control of tradescantia, OMB, Himalayan balsam, cherry, wattle, karaka seedlings, sycamore, bindweed and buddleia by individuals, working bees and groups. **TPG**

Nursery/Planting Update

Just over 1,230 planted so far. Jonathan Anderson of WCC also had a podocarp allocation. Following a Park walk-through with Adam Groenewegen, Peter Reimann provided a list of planted areas and numbers for each.

Animal Pest Control

<u>Trap Scores</u> - Trap scores since 2008: [288] rats/mice,17 stoats/weasels, 18 hedgehogs.

Bait Stations - Much consumption of block bait by rodents.

<u>Rabbits</u> - Still in evidence along the Trelissick Crescent verge, on the grass slope below entrance 3 (5 shot recently) and along the railway line. Plant protection is being employed. Henk Louw says the rabbit problem is "widely shared throughout the city and we are trying to address all heavily affected areas."

Oban Track/Bridge

<u>Engineering</u> - Trevor Butler, the engineer from Frame Group Ltd, advises that design and preparation of tender documents should finish late this month. Tim Harkness and Peter Reimann will then review the programme for future work and sent this to Frame for agreement. *Frame Group/Tim Harkness/Peter Reimann*

Consents - Frame Group will then work on WCC and GW consent applications. Frame Group

<u>Construction Contractors</u> - Tim Harkness from WCC has three potential construction contractors - Outsiders Landscaping, Tascon Ltd and Fulton Hogan. As soon as he has reviewed the design and documentation from the Engineer, he will write the request for quotation. *Tim Harkness*

Construction Tender Evaluation - Jointly by WCC/TPG. Apart from pricing, the following needs to be covered:

lowest price could lead to short-cuts and 'extras', experience, proposed methodology, quality/thoroughness of proposal, feedback from others.

Access from Oban Street - WCC will be funding and managing the access from Oban Street down the road reserve and the legal right-of-way. He has discussed entrance work/fencing/landscaping with the owners of 112/114 Oban Street. *Tim Harkness*

<u>Track</u> - TPG will need to upgrade the existing track to WCC 'Walking Track' standard and do the short streambank section to the bridge. Tim Harkness/Adam Groenewegen/a WCC intern/Barry Durrant/Peter Reimann examined the route on 15th November. Upgrading the middle section is straightforward and Barry Durrant will work on this. *Barry Durrant*

Tim Harkness will revisit and mark route changes at the upper and lower sections. Tim Harkness

<u>Vehicle Track Changes</u> - The north end of the bridge will connect with the vehicle track, locally elevated to keep the bridge above floods and floating trees/branches. The vehicle track will need to be diverted slightly to allow room for the north end of the bridge.

Completion - If there are no further delays, all should be complete by June/July 2020.

<u>Funds Secured</u> - \$87,760.50 so far, including a donations just received from Transpower (\$20,000), the Ron and Edna Greenwood Environmental Trust, Tararua Tramping Club Michael Taylor bequest and individuals, some via Givealittle - gratefully received.

Funds Required - Based on a ball-park estimate from the engineer, we should have enough.

<u>Financial Handling</u> - NCDRA, as an incorporated society, has agreed to act on behalf of TPG on all financial transactions and have set up a dedicated ANZ 'Serious Saver' account. As there will be regular outgoings interest will be negligible. It was agreed that any interest benefits of using term deposit(s) instead would be negligible. Murray Pascoe of NCDRA confirmed that the \$20,000 from Transpower is in their dedicated ANZ account.

HPPA will eventually need to transfer the money they are holding to NCDRA for progress payments. HPPA's term deposit of \$51,763 matures on 20 March 2020.

Lower Kaiwharawhara Stream and Estuary/Reclamation

<u>Kaiwharawhara Estuary and Point</u> - William Woods of Centreport will give an update of plans for developments in the area at the next Sanctuary to Sea meeting on 3rd December.

Submissions

<u>128 Trelissick Crescent 17-unit Development</u> - Bill Hester has recently asked WCC if there is any updates. WCC advise the application is still 'in suspend'. It doesn't automatically expire and could potentially remain on 'suspend' indefinitely.

Ministry for Environment - Healthy Waterways and Freshwater Management Discussion Document - TPG lodged a submission on 'Action for Healthy Waterways' and the associated 'Draft National Policy Statement for Freshwater Management', looking for more action on fast stormwater run-off, sedimentation, pollution, monitoring and fish passage. TPG's submission, on the 'Current Issues' page of our website, is only one of 17,500 received. They will be reviewed by an Advisory Panel. Ministers are expected to have the regulations in force by mid-2020.

<u>Kilmarston Development (Above Ngaio/below Crows Nest)</u> - As per previous minutes, WCC's Jonathan Anderson will advise if anything happens - nothing yet. He says the application is "open-ended and can sit in a state of inaction pretty well indefinitely." **Jonathan Anderson (WCC)**

Appeals to Environment Court on the Proposed GW Natural Resources Plan - TPG has received copies of appeals from F & B, Rangitāne tū Mai Rā Trust and Rangitāne o Wairarapa Incorporated Society, Z Energy Ltd/Mobil Oil NZ Ltd/BP Oil NZ Ltd, Meridian Energy Ltd, Porirua City Council, Transpower, Wellington Water Ltd and Wellington Fish and Game Council, CentrePort Limited/CentrePort Properties Limited - all via lawyers.

Finance

A cheque for \$47.50 from 'Givealittle' for the Oban track bridge was approved and handed to Murray Pascoe of NCDRA. The 'Givealittle' source has now ended.

Other

<u>Groups in Park</u> - Thanks to Conservation Volunteers (2 visits), Scouts, Ngaio Brownies and MBIE Legal, for their work in the Park. Khandallah/Northland Cubs, Raroa Intermediate and Treasury are due in December.

<u>Urban Ecology Research Symposium</u> - Conducted by VUW/WCC and the Centre for Biodiversity and Restoration Ecology (CBRE) at Zealandia and attended by Andrew Swann and Peter Reimann.

<u>Silverstream Clean-up</u> - Peter Reimann participated in a clean-up of the Silverstream below the new housing development organised by Mountains to Sea Wellington and Amanda Valois of NIWA.

<u>Continuous Level Monitoring at Lower Kaiwharawhara</u> - Sam Gundersen of GW has sent data on this (very 'peaky' during rain). Peter Reimann forwarded this to Trevor Butler of Frame Group as it may be useful for the GW consent application for the Kaiwharawhara Stream bridge upstream.

Sanctuary to Sea Meeting - This will be at Zealandia on 3rd December at 5.30 PM

<u>QE2 Trust Covenanting below Eastern End of Trelissick Crescent</u> - Some of the properties extend across the Forest Remnant Track. Peter Reimann has checked boundaries. Some of the owners may be interested in covenanting to the QE2 Trust.

<u>Light Shields in Lower Kaiwharawhara</u> - A local resident, Lucy Alcock, living above the lower Kaiwharawhara commercial area has followed up her previous contacts with ExxonMobil and NZ CourierPost requesting sharp edges to their LED lights to align with the site boundaries (effect on biological cues for wildlife in the ecological corridor). They are still investigating.
