The minutes of the 198th meeting, held on 1st March 2022, were confirmed.

WCC Items

Fish Passage improvement in catchment – TPG looks forward to the final report on barriers in the Kaiwharawhara catchment and proposals for improving fish passage, particularly in the 150 m culvert on Kaiwharawhara Stream below the Park (see minutes of the TPG meeting 29 June 2021). Peter Reimann will follow this up with Danelia Biaggio. Peter Reimann

Ngaio Gorge Road Stabilisation Project - Work on the slips should continue until the end of 2022. For more information, photos and a video, see Projects – Ngajo Gorge stabilisation – Wellington City Council.

At the final phase of the project, WCC will engage a landscape architect to plan landscaping arrangements, where the areas are disturbed due to construction work. Peter Reimann will ask for details of the architect, the plant supplier, what species, who does the planting and when. Peter Reimann

However, no planting will take place in the area immediately behind the retaining walls to facilitate future inspections and maintenance work.

New map-boards - Installed. The adjacent dog exercise area map boards, and 'track closed' signs should be removed. Tim Harkness

Dog Control update –The sign at the Oban track entrance is confusing, as some people may think on-leash applies to the whole park, whereas currently, the off-leash areas are in the valley and from all entrances except from Oban Street. TPG advocates for the Oban slope entrance to be off-leash, such as below the Hanover Street and other entrances. Myfanwy Emeny says that this will be part of the review of dog exercise areas and the dog policy. When will this happen? Myfanwy Emeny

Storm Problems

- Sewer line repair next to Korimako Stream Work to fix the undermined sewer line foundations on the stream bank below Waikowhai Street is finished. The contractor Fulton Hogan has supplied 80 reparation plants for damage to previous planting in the area.
- Bridge 4 Washed downstream onto Bridge 5. Now replaced. Minor cleaning up remains to be done. [The contractor Chris Logan advises that a rewarewa close to the approach track should be moved. *Peter Reimann*]
- Bank erosion affecting vehicle track alongside Kaiwharawhara Stream A safety barrier next to the vehicle track has been extended. Date of fix of the vehicle track to be advised. Tim Harkness
- Bank erosion downstream of debris trap Track closed. Engineer Tonkin and Taylor has been employed to investigate re-positioning the track to above the retaining wall. Tim Harkness
- Track washout just upstream of bridge 6 WCC decided not to restore this section of the track.

Other track improvements needed – Just downstream of Wightwick's Field (beyond the track junction); rocky section between bridges 3 and 4, canyon track downstream of bridge 6. *Tim Harkness*

<u>Bridge numbering</u> – All seven bridges need number plates (some are without, or non-standard). *Adam Groenewegen*

<u>Parking improvement at Waikowhai Street entrance</u> – Downer was to undertake this work for WCC last summer. Peter Reimann will ask for an update. **Peter Reimann**

<u>Leaking sewer pipe</u> – The leaking sewer pipe crossing Kaiwharawhara Stream downstream of bridge 6 has been fixed by WW.

Jonathan Anderson will follow up with WW about the previously advised minor leak into the park from the houses on the eastern side of Trelissick Crescent. *Jonathan Anderson*

Pest Plant Control

<u>Control by WCC/contractor</u> – Kaitiaki o Ngahere has sprayed tradescantia with a new chemical. It takes a few days for the effects to show. It would aid safety for TPG volunteers to know when and where areas have been sprayed, so that TPG can avoid manual removal there. *Illona Keenan*.

<u>Control by TPG</u> – TPG continues with manual control of tradescantia, OMB, Himalayan balsam, cherry, wattle, karaka seedlings, sycamore, bindweed, blackberry, climbing dock and buddleia by individuals, working bees and groups. **TPG**

<u>Maintenance of the streamside '51 memorial trees' site</u> – Carried out recently by CVNZ to assist the Interfaith group. <u>Blackberry</u> – Grubbed out from grassy areas downstream of bridge 5 and upstream of the debris trap – the latter to be planted with natives.

Nursery/planting update

450 came from WCC on 13 May 2022, including 80 unlisted grasses. Jonathan Anderson has ordered 20 canopy trees. Peter Reimann's home nursery has about 120 mixed species. 80 reparation plants were delivered (see 'Storm Problems' above).

Animal Pest Control

<u>Traps</u> – Totals from 2008 to early July 2022: 22 stoats/weasels, 537 rats, 18 hedgehogs.

Since the last meeting (1 March): March = 3 rats, April = 1 rat, 1 stoat, May = 1 rat, 1 stoat, June = 1 rat.

A24 catches (rats+mice): Jan = 4, Mar = 9, Apr = 7, May = 5.

Bait Stations - Much consumption of block bait by rodents.

Rabbits - Often seen on or below Trelissick Crescent.

Kaiwharawhara Estuary – New ferry and rail facilities

KiwiRail provided an update at the 22 June Sanctuary to Sea meeting. All is going to plan – ferries due 2025, 2026.

WCC's Jonathan Anderson has expressed interest at some time in the future.

<u>Barry's track to Oban Street sign</u> – Barry Durrant advises that his sign 'Barry's track to Oban Street' near bridge 7 was removed. He has recovered it. Peter Reimann will investigate why and by whom. *Peter Reimann*

Memorial trees – WCC's Myfanwy Emeny organised three heritage trees to commemorate Gottfried Theiler, Dorothy Douglass and Olaf John, who died last year. Gottfried's pukatea was planted on 24 June at the grassy spot downstream of bridge 5 on 24 June, attended by three generations of his family. Dorothy's miro will follow on 9 July and Olaf's titoki on 16 July.

ORCA walk in park – Peter Reimann took an ORCA party for a park tour outlining the history and problems.

<u>Seat beyond end of bridge 7</u> – Jenny Lewis suggested that a peaceful/beautiful place for a seat would be just beyond the end of bridge 7 on the southern side. She will investigate [via <u>WCC seats.</u>]

<u>Stream bank erosion from dogs</u> – Angus Napier expressed concern about the continuing bank erosion caused by dogs running down to the stream [the worst is downstream of bridge 4].

<u>Historical photos from Frances Lee</u> – Anne Tuffin has digitised Frances' photo albums – a valuable record of park history since 1991. Anne will investigate repositories for the hard and digitised copies. *Anne Tuffin*
