Recognition of Peter Reimann's 18 years as Chair

Frances sent a message acknowledging Peter's wonderful contribution to Trelissick Park as the TPG chair.

The group thanked Peter for his dedication and leadership over his term as Chair.

Mike Lear

Sadly, regular working bee stalwart for 9 years. volunteer Mike Lear died peacefully at his home surrounded by his family on 28 February.

New TPG Convenor

Anne Tuffin convened the committee meeting for the first time. She noted she has very large shoes to fill.

WCC Items

Sewerage leak - There is a long-term sewerage leak at the north end of Otari contaminating the Kaiwharawhara Stream through Trelissick Park. TPG will send a submission to WCC in April. Anne Tuffin in coordination with lan Turk/Tim Park

Fish passage improvement in catchment – See previous minutes. Updates are awaited. Joshua Forrest/Jakob Lechner

Ngaio Gorge Road Stabilisation Project – Planting of grasses and mulching at layby near entrance 5 complete (Adam Groenewegen and TPG). Rubbish bin reinstalled at entrance 5.

Clearing blackberry area for podocarp planting - Applied Biosecurity Solutions have cleared blackberry from Jonathan Anderson's proposed podocarp grove site upstream of bridge 7 above the true right bank - about 20m x 50m. They will do another sweep of re-growth. To be planted in 2025. Applied Biosecurity Solutions, Jonathan Anderson

Storm problem - bank erosion affecting vehicle track alongside Kaiwharawhara Stream - A safety barrier next to the vehicle track has been extended. Rock armouring of this section is proposed. Tim Harkness

Track improvements - This year WCC's Tim Harkness has \$9K for work along the stream side track from bridge 6 heading down-stream. It was noted that the track is closed while the work is done, with a detour in place. Tim Harkness

Tim is looking to spend around \$10-15K a year for the next 3-5 years on improvements in the Park. Tim Harkness

Debris trap remediation – The bent rails have been somewhat straightened, but the trap design may eventually need a re-think.

Pest Plant Control

Tradescantia clearing – Jonathan Anderson cautions against clearing tradescantia from dry forested slopes because it harbours valuable insects and slows run-off/erosion during heavy rain. In the plant order from WCC, TPG is including groundcover species in the plants for 2024, which may assist in overcoming these problems. *Peter Reimann*

Weed control agreed to be covered by WCC - update needed. Illona Keenan

- WCC/Kaitiaki cherries in the vicinity of Angus Napier's ring-barking upstream of bridge 2 above true right bank.
- WCC/ Downers OMB on steep slopes above Ngaio Gorge Road up from the layby. To be done by Downers traffic management - needs abseil access and prone to rocks falling onto vehicles below (use catch netting?)
- WCC/Kaitiaki Marilyn Hester's request for Kaitiaki to spray a tradescantia infestation off Trelissick Crescent just under the white fence at the road strengthened site opposite #49. The road crew laid a metal mesh over the ground where they reinforced the slip, and the montbretia and tradescantia have grown up through it. She can't access the roots to eradicate the weeds. The tradescantia is making its way down into the park. The bank is very steep.
- WCC/Kaitiaki Below the Scout Hall at the end of Hanover Street towards the awa (stream) OMB and Japanese honeysuckle.
- WCC/Kaitiaki On the true right of the awa above the gorge climbing asparagus and OMB.
- Another sweep to control the climbing asparagus below Oban Street (if required).
- Japanese honeysuckle on the old planted slip site by Hanover St bridge (#6), this will need spotters on the tracks.
- Some other scattered sites to follow up.
- WCC will get an arborist to look at the cherry about 10 m below gorge lookout park map grid reference 019 027 (approx.) – needs abseil from handrail (photo supplied to Illona).
- Drone survey in autumn (with cherry control happening in the meantime).

Weed control by WCC to be covered by around \$10K(?) of \$50K donation* - update needed Illona Keenan

- Cherry in the Korimako Stream gorge. There are around six on the steep slopes of the gorge, originally visible from the train when in bloom, but spotting follow-up was too late – will have to wait for autumn colours or spring blooms in 2024. See drone survey above
- Cherry/sycamore along railway line (down from Crofton Downs station) and below Hanover Street needs access agreement with KiwiRail. Illona emailed KiwiRail about this on 26 September 2023.
- Jonathan Anderson will advise locations of evergreen buckthorn to be controlled. Jonathan Anderson

<u>Control by TPG</u> – TPG continues with manual control of tradescantia, OMB, Himalayan balsam, cherry, wattle, karaka seedlings, sycamore, bindweed, blackberry, climbing dock and buddleia by individuals, working bees and groups.

Nursery/planting update

For planting in 2024

500 plants from WCC nursery due on 3 May - mainly ground-cover species and infill.

F&B nursery is providing 20 cabbage trees and 20 *Carex geminata* for Finn's spot downstream of bridge 7. *Richard Grasse*

Sedges/rushes for inanga spawning – separate order covered by part of the \$50K donation* (see under 'S to S projects' below). *Nate Rigler (S to S)*

<u>For planting in 2025</u> – Podocarps for Jonathan Anderson's streamside blackberry patch upstream of bridge 7. Note: some of the \$50K donation* may need to be kept if WCC has insufficient supplies – need to contact WCC's Anita Benbrook now to pre-order. Anita's records of emergent and canopy tree production from 2005 – 2023 (email 6 October 2023) may help. *Jonathan Anderson*

Animal Pest Control

<u>Traps</u> – Since the last meeting on 9 November: 7 rats and one hedgehog. Totals from 2008: 23 stoats/weasels, 616 rats, 21 hedgehogs. The above totals do not include recent A24 kills.

All the official DoC200 trap kills are now recorded in the TrapNZ national database for traps, including most historic data. It includes the Scots College victor traps, but not the block bait stations/possum baitsafe stations/A24s.

Bait Stations – Consumption of block bait by rodents in the 30 bait stations indicates heightened activity.

<u>Rabbits</u> – Often seen on or below Trelissick Crescent. Debbie reported that rabbits are about to be hit up on Skyline. Monitoring – Debbie reported on tracking tunnels/stations in the Park. Along with Otari, no rats have been seen.

Kaiwharawhara Estuary – New ferry and rail facilities

Project halted by new government due to cost issues. Awaiting advice on what next.

At the final site visit on 31 January Annie Graham (GW) advised that the site looks tidy and well-stabilised, so GW is comfortable with the sediment retention pond being filled in. The penguin exclusion barrier will likely be removed as there is a risk that if left in place it could trap any penguins that may get through.

The temporary wharf and the new bridge over the Kaiwharawhara Stream will be left in place for the time being so that they don't cause unnecessary disturbance by removing the structures and putting them back in if the project does start up again in the future.

Exposed areas have been sown with grass seed polymer, and the flat areas of the site are fully stabilised with aggregate. GW is confident that the site will be left in a condition that will ensure there is no risk to the stream, estuary, or coast.

Sanctuary to Sea projects

CentrePort staff visits for work in park - On hold due to halting of new ferry project.

<u>Catchment volunteer days</u> - Nate is keen to promote these, the first one for the park was in combination with the scheduled working bee on Sunday 3 December below Oban Street.

<u>Inanga spawning project</u> – On 6 July 2011 a team from OWB planted 300 riparian species on DOC land on the true right bank of Kaiwharawhara Stream downstream of the Hutt Road bridge. It is proposed to add riparian plants on the opposite bank (next to Spotlight), possibly funded by much of the \$50K donation* to TPG. The planting site is below a concrete wall, normally submerged to about 0.5 m depth and subject to destructive flood flows. Following a recent site visit by S to S, DoC and TPG, Nate Rigler is investigating plant protection methods and talking with a wide range of interested parties, e.g. Taranaki Whānui and Morphum Environmental. Nate noted that the Kaiwharawhara Stream is the ONLY Wellington stream with an estuary with open access to the sea - very high conservation importance. *Nate Rigler (S to S)*

A recent visit by Mountains to Sea established the boundary between saline and fresh water during a king tide (just downstream of the mid-stream flax bush). A few inanga were observed. Nate noted that Inanga eggs are laid on grasses/sedges at a king tide and need to dry out before the next king tide when they are washed off.

It was agreed that \$25k from Frances Lee's donation to be used in the best way possible to support the estuary and the Inanga Spawning project. Nate indicated that part of this funding could possibility be used for 'seed' funding. VUW is interested in supporting the project with additional research grants. As an experiment, it is proposed to fasten planter boxes to channel wall to hold grasses. TPG will write to Zealandia confirming the \$25k commitment to the project. *Anne Tuffin*

<u>\$50K* from a generous donor</u> – Ian Shearer of HPPA has moved this to a savings account (4.5% p.a. interest). \$25k will be allocated to the inanga spawning project. The remainder will be used for weed control and signage in the Park. (see on p.2 under 'Inanga spawning project'). As HPPA/WRA is winding down, **it was resolved** that the \$50k (plus interest) will be transferred to NCDRA. (NCDRA handled bridge 7 donations on TPG's behalf in the past. NCDRA has offered to open a separate account to hold the funds. A letter will be written to NCDRA authorising the transfer of funds. *Anne Tuffin / Ian Shearer*
